### No Sharing of Personal Information

DAYSRING VILLA never sells, rents, leases or exchanges your personal information with other organizations. DAYSRING VILLA assures you that the identity of all who contact us through this Web site will be kept confidential. DAYSRING VILLA may occasionally send mailings on behalf of other organizations or ministries when their interests align with DAYSRING VILLA . **IMPORTANT:** *Unless a donor requests anonymity, their names will be printed in our annual report. ### Security

DAYSRING VILLA is committed to ensuring the security of your personal information. To prevent unauthorized access, maintain data accuracy, and ensure the proper use of information, we have established and implemented appropriate physical, electronic and managerial procedures to safeguard and secure the information we collect online. DAYSRING VILLA uses Internet Encryption Software, Secure Socket Layer (SSL) Protocol when collecting or transferring sensitive data such as credit card information. Any information you enter is encrypted at your browser, sent over the public Internet in encrypted form, and then de-encrypted at our server. Once we receive your credit card information, it is accessible only to a small number of trusted DAYSRING VILLA employees who have been specially trained in processing this information.

### Cookies

From time to time, we may send a "cookie" to your computer. A cookie is a small piece of data that is sent to your browser from a Web server and stored on your computer's hard drive. A cookie can't read data off your hard drive or read cookie files created by other sites. Cookies do not damage your system. We use cookies to recognize you when you return to our sites, or to identify which areas of our network of Web sites you have visited (i.e. e-commerce sites, etc.). We may use this information to better personalize the content you see on our sites.

Many Web sites place cookies on your hard drive. You can choose whether to accept cookies by changing the settings of your browser. Your browser can refuse all cookies, or show you when a cookie is being sent.
