From a Pastor's Heart . . .

And A Lawyers Perspective

The Reverend Joseph Parker, Jr., D.Min., Esq. pastor of David Chapel Missionary Baptist Church in Austin, Texas, heard recently at a Tulsa conference, offers a unique perspective toward the issue of domestic violence. Besides being a minister, he is also a renowned attorney. Here are his 15 reasons why pastors should confront the issue of domestic violence with the full weight of their Christian influence and why attorneys should do the same with the full force of the legal system.

- ⇒ The dignity of each person—each human being is created in the image of God.
- ⇒ Each person has the right to be free from hurt, harm, abuse and violence.
- \Rightarrow Each person has the right to the pursuit of happiness.
- ⇒ A person should love his or her neighbor as himself or herself.
- ⇒ Violence is outside the will of God.
- ⇒ Domestic violence is a violation of right relationships.
- ⇒ Domestic violence creates a destructive environment.
- ⇒ Domestic violence denies the faith community the full participation of some of its members in its circle of trust.
- ⇒ The faith community is a community of accountability and transformation.
- ⇒ The faith community should be concerned about physical and spiritual trauma.
- ⇒ The faith and legal communities must be protectors of freedoms and legal rights.
- ⇒ The faith and legal communities must be actively engaged in providing solutions to societal ills and evil.
- ⇒ The faith and legal communities must actively encourage a positive quality of life for all persons.
- \Rightarrow The faith and legal communities must be seekers and makers of justice and mercy.
- ⇒ The legal community has a public-service license and the faith community has a faith-based license, both of which should promote justice and the public good. ❖

Good Things Happening



I know many seeds have been planted in the lives of 53 girls and babies that we have cared for in the past two years.
